# BURSARY APPLICATION

Bursaries are designed to provide assistance to families who are experiencing financial difficulties which threaten the ability of the student to learn a musical instrument and attend St. Columb's School of Music. Bursaries will run from September until the End of Year Concert (June). Bursaries are limited to one bursary per student.

Bursary Guidelines:

- 1. The deadline for a completed bursary application and supporting documents is Friday 16th August at 5pm. Incomplete applications or applications received after this date will not be considered.
- 2. Each application is considered by the Award Committee, whose decision is final. The decision will be communicated to parents.
- 3. The bursary award scheme is designed to provide assistance to families who are experiencing financial difficulties which threaten the ability of the student to learn a musical instrument. It is expected that parents will exercise integrity and honesty at all times when making an application for a Bursary.
- 4. Applicants for bursaries must demonstrate real financial need; families who may be classified as low income, but have substantial assets may be ineligible to receive a Bursary.
- 5. Once an award is approved, parents will be sent information regarding the amount of the Bursary, the duration and any additional conditions e.g. maintaining a level of achievement in certain subjects.
- 6. Students receiving a Bursary are expected to respect and comply with all school Policies and Procedures at all times and to make continued progress in their area of excellence as recognised in the Bursary Award. Should this not be the case, St. Columb's School of Music reserve the right to terminate the Bursary at the end of the academic year in which failure to adhere to the above conditions has been raised with the student and/or their family.
- 7. Any change in financial circumstances must be reported to the school. If the change in financial circumstances means the student no longer satisfies the criteria for an award, it will be discontinued. Failure to divulge to the school any requested information, or a change in circumstances could result in immediate cancellation of a bursary.
- 8. All applications are treated in the strictest confidence.

#### **Application Process**

Early submission of Bursary applications is advised. Please include the following documents with applications;

- A completed application form
- Proof of eligibility if required.
